IN THE MATTER OF an application  
by The New Brunswick Electric Power  
Commission for approval of a change  
in its rates, tolls and charges.

ORDER

WHEREAS The New Brunswick Electric Power Commission (NB Power) has applied to the Board by Application dated April 20, 1990, for approval of a change in its rates, tolls and charges by eliminating the General Service II rate, except as it is applied to premises serviced at that rate on the effective date of the change, for as long as the service entrance size to those premises remains unchanged;

AND WHEREAS the General Service II rate applies to that category of customers who use electricity for purposes other than those specifically covered under residential, small and large industrial, street lighting or unmetered classes and who use electricity as the only source of energy for cooking, space heating, water heating and all other services;

AND WHEREAS NB Power has requested that the Board inquire into those matters enumerated in Section 43 of the Act, and any other matters which the Board is lawfully entitled to inquire into which will affect the rates, tolls and charges prior to rendering a decision on the specific change in its rates, tolls and charges as hereinbefore set forth;

AND WHEREAS the Board considers that certain background or generic issues, such as NB Power's accounting and financial policies, should be reviewed in public hearings prior to the public review of the requested change to the General Service II rate;

AND WHEREAS the Board expects that separate public hearings would be held to review such matters as:

- . accounting and financial policies
- . cost allocations and rate design
- . energy efficiency programs and load forecasting
- . other matters as determined to be appropriate

and that the hearings would most likely be held sequentially.

NOW THEREFORE IT IS ORDERED THAT:

- (a) A pre-hearing conference shall be held in Ballroom 1A of the Delta Brunswick Hotel, Saint John, N.B. on Wednesday the 13th day of June, 1990, commencing at 10:00 o'clock in the forenoon and from day to day as necessary, when and where intervenors and the Applicant should attend and make representations as to the generic issues to be reviewed and to set dates for those hearings as well as to set the date of the Public Hearing to review the requested elimination of the General Service II rate and the procedure to be followed prior to and at the Public Hearings and as to any other matters in respect thereto.
- (b) Notice of the date for the holding of the Pre-Hearing Conference in respect of the Application and the procedure the Board intends to follow to facilitate the participation of intending intervenors, be published, in the form or substantially in the form attached hereto marked "A", in either the English or French language as may be appropriate having regard to the principal language of publication, twice in each of the following newspapers:



consider changes to the General  
Tariff of The New Brunswick Electric  
Power Commission.

NOTICE

The New Brunswick Board of Commissioners of Public Utilities (the Board) has received an application from The New Brunswick Electric Power Commission (NB Power) for approval of a change in its rates, tolls and charges.

NB Power has applied for approval to eliminate the General Service II (Commercial All-Electric) rate, except for any premises serviced at that rate on the effective date of the change and as long as the service entrance size remains unchanged.

NB Power has proposed and the Board agrees that prior to rendering a decision with respect to the General Service II rate certain background or generic issues should be reviewed in public hearings. These generic hearings would review such matters as the accounting and financial policies of NB Power which can have a significant impact on its rates.

The Board therefore intends to hold a series of public hearings to review each of the relevant generic issues prior to the public hearing to review the specific request for approval of a change to the General Service II rate.

NOTICE IS HEREBY GIVEN that the Board has ordered the following:

- (a) That a prehearing conference shall be held in Ballroom 1A of the Delta Brunswick Hotel, Saint John, N. B. on Wednesday the 13th day of June, 1990, commencing at 10:00 o'clock in the forenoon, when and where intervenors and the Applicant should attend and make representations as to the generic issues to be reviewed and to set dates for those hearings as well as to set the date to review the requested elimination of the General Service II rate and the procedure to be followed prior to and at the Public Hearings and as to any other matters in respect thereto.
- (b) Persons intending to intervene must notify the Board in writing, at the address below, no later than Friday the 8th day of June 1990.
